NEED FOR THE RULE(S)

This action is necessary to set 2026 hunting season regulations and controlled hunt tag numbers for game mammals.

Amendments relating to electronic scope devices and e-tagging are needed to clarify the existing regulations. These changes are needed to make compliance and enforcement of the allowed types of scopes and the necessary steps for e-tagging of game mammals clearer for both hunters and for the Oregon State Police. The formula used to allocate LOP tags in mule deer range areas will be impacted by the new Deer Hunt Area system. These proposed amendments will allow for a new framework, which accounts for mule deer population ranges and corresponding levels of concern. If these amendments were not adopted Oregon Department of Fish and Wildlife (department) would be unable to issue LOP tags in the affected areas. Similarly, since the number of Guide and Outfitter Tags are based off the proportion of Nonresident tags drawn in the previous year and the new Deer Hunt Areas creates a new system with new hunts, rule amendments are needed for the department to allocate tags to be available to guides in this first year.

The controlled hunt application fee increase is needed to implement recently adopted legislation (HB 2342 2025). The

increase is needed to support the department's programs into the future and accounts for recent and expected increases in costs. This administratively set fee was last changed for the 2010 license year.

FISCAL AND ECONOMIC IMPACT:

These regulations are not expected to result in significant economic or fiscal impacts to local governments or the public. Fiscal and economic impacts discussed in this document pertain only to the proposed rules at the time of writing of this fiscal impact statement.

COST OF COMPLIANCE:

(1) Identify any state agencies, units of local government, and members of the public likely to be economically affected by the rule(s).

A. State agencies that could be affected by these rules are the Oregon Department of Fish and Wildlife (wildlife management costs) and the Oregon State Police (enforcement costs). The amendments that further clarify the prohibition on the use of any electronic scopes that receive information and infrared/thermal devices will make the enforcement of existing hunting restriction easier for Oregon State Police officers to enforce. No major changes from the current levels of these agencies' operations or expenditures are expected as a result of adoption of these particular rules.

B. No units of local government are expected to be significantly affected by these rules. No significant changes from the current levels of any local agencies' operations or expenditures are expected as a result of the establishment of these hunting seasons and regulations.

C. The public is affected by the rules relating to the hunting seasons. Various sectors of the public economy (hunters, suppliers of hunters, and the general economy) will experience varying impacts. The economic impact of changes in hunting rules depends primarily on the changes in hunting opportunities associated with the rule changes and related

effects on direct expenditures by hunters. These effects are best measured by estimating the magnitude of changes in the number of hunter days and estimating the resulting changes in expenditures made by hunters, and the associated effects on personal income.

In general, no significant changes in hunter participation levels are anticipated in 2026 compared to 2025, assuming adverse weather and environmental conditions are not experienced between now and the 2026 seasons.

The total (direct, indirect and induced) effects on personal income in the areas surrounding the associated hunting areas and statewide are the result of the direct expenditures on goods and services made by hunters during their hunting trips. Through the "multiplier process", there is a resulting increase in economic activity and personal income in the general economy of the area and the entire state. A review of statewide hunting expenditures is presented below to provide a background on the economic impact of hunting in Oregon.

An Earth Economics study (Mojica et al. 2021) estimated that an individual hunting participation day results in an average expenditure of \$96 per hunter per day (base year 2019). In inflation adjusted (May 2025) dollars, the average expenditure per hunter day in Oregon would amount to \$120.

The relationship between direct, indirect, and induced personal income from the direct trip expenditures per hunter day can be estimated based on response coefficients developed from an economic input-output model. The most recent economic contribution study, an Economic Analysis of Outdoor Recreation in Oregon, by Earth Economics also provided updated statewide figures on hunting-related expenditures (using 2019 data). The survey findings estimate Oregon's total hunter related expenditures to be \$228 million in 2019 dollars. In 2024 dollars this is \$280 million in expenditures. These expenditures are associated with the generated economic impact of 2,219 jobs and \$73 million in wages (\$90 million in 2024 dollars) and \$11 million in state and local taxes (\$14 million in 2024 dollars).

Total hunter expenditures are not currently estimated annually at a statewide level for Oregon. However, there are some figures available that provide additional context on hunter expenditures. According to data from the 2011 National Survey of Fishing, Hunting and Wildlife-Associated Recreation, total hunter expenditures in Oregon were about \$239 million in 2011. In 2024 dollars, this would mean \$343 million in expenditures. The most current 2022 National Survey of Fishing, Hunting, and Wildlife-Associated Recreation survey now focuses on national data only and no longer provides state level expenditure estimates. However, the national level hunting expenditure data is worth citing. Survey results show that nationally for all hunting types, trip expenditures per day is \$51 and annual trip expenditure per hunter is \$857 dollars (base year 2022). While differing survey methodologies make comparison across surveys difficult, a review of past survey results does suggest that on average Oregon hunters have higher expenditures than the national figures.

The estimates above will be reasonably good measures of the impact on total personal income per hunter day to the extent that the dollars spent on the hunting trips would not have been spent on other activities or commodities in Oregon had there been no hunting seasons. The economic impacts of hunters' expenditures on durable equipment associated with hunting are not included in the estimates above. For example, durable equipment would include expenditures that individuals plan to use for a number of years, such as an all-terrain vehicle (ATV) or RV. These equipment expenditures are not necessarily related to hunter use in a simple linear fashion, and hence, may not be significantly affected by marginal changes in seasons. However, there is probably a positive relationship between hunting opportunities and equipment expenditures, particularly in the long run.

The effect of changes in numbers of hunters and hunter activity on personal income in the regions and at the state level can be estimated using the personal income impact per day estimates. However, the aggregate impact depends on the

magnitude of the changes in the number of hunters and hunter days. As indicated above, there are relatively minor changes expected to the number of hunters and net hunting days due to changes in game mammal regulations and controlled hunt tag numbers for 2026 compared to 2025. However, depending on the weather next winter and other environmental factors affecting survival, there may be changes in the amount of controlled hunt tags available in 2026, especially for deer hunts. Obviously, the magnitude of these changes cannot be predicted, but should a hard winter occur, the effects on tag availability could possibly be greater than the effects of any changes in these proposed regulations.

One area where there may be an effect on the number of hunts is specific to the number of mule deer tags available in 2026. In 2026, the department will transition to the management of hunts from Wildlife Management Units (WMUs) to Deer Hunt Areas. These Deer Hunt Areas better align with mule deer populations and management goals and will improve population monitoring and management responses. There is a potential for a 9% decrease in the number of tags available for mule deer hunting in eastern Oregon. Hunters will also need to invest time to learn the new Deer Hunt Area boundaries since these are different from WMUs. The switch to Deer Hunt Areas may alter tag quantities available in the short run, but by allowing for a more refined management system, this will be positive for hunters in the long run and more beneficial for the management of mule deer populations in Oregon.

The current restrictions in some of the hunting seasons for game mammals, such as limiting tag numbers and season dates, can be viewed as restricting opportunities and reducing positive economic impacts in the short run. However, conservation through adjustment of these and other game mammal hunting seasons is intended to perpetuate the resources at optimum levels over the long run. Failure to restrict harvests of game animals to allow escapement for reproduction would result in reduced hunting opportunities in the future. The proposed regulations strike a balance that will sustain game mammal population levels and maintain future benefits.

Regarding the amendments needed to reassess how LOP tags are allocated to landowners in and around Deer Hunt Areas, there is potential for some landowners to be affected. The department must implement a new formula to allocate the number of available LOP tags based off the new Deer Hunt Area boundaries, while also considering deer population ranges and the level of concern for herd health. Impacts would be limited to landowners within given hunt areas that receive 2026 tag allocations that might differ (higher or lower) compared to previous years using the old system. Amendments are not expected to result in any major change to the LOP program operations. It is not possible for the department to estimate the amount of any potential fiscal impacts to landowners, as impacts would be felt on the scale of the individual landowner dependent on where their landholdings are in respect to the new Deer Hunt Area boundaries. In addition, any fiscal impact would also be affected by whether landowners use tags for personal use or for the purpose of generating income from recreation access. The proposed amendments ensure that LOP tags in eastern Oregon will be available in 2026.

The proposed amendments will also address the impact of switching from WMUs to Deer Hunt Areas for Guide and Outfitter Tags. The department allots tags to be available to guides and outfitters by linking this to $\frac{1}{2}$ of the number of nonresident tags drawn in the previous year. Since the new management system will effectively modify mule deer hunts with new hunt names and boundaries, amendments propose a solution for the first year to ensure tags can be allotted to guides and outfitters. In 2025, 947 tags in total were allocated to guides, of these tags 109 were used by this group. The proposed solution considers this and the ratio in past years to allocate tags in this first year of Deer Hunt Areas. There is still potential for guides and outfitters to be impacted, since the geographic boundaries of hunt areas are changing, a guide's typical base camp or favorite spot could change to a different unit with different odds for their tags to be drawn. It is not expected that odds will change drastically from current, however, it is recognized that this could have an impact. It is difficult to know the cumulative fiscal effect of this impact, as it will vary across guiding businesses, some guides may be more equipped to adjust their strategy and decide to pick up tags for hunts in different areas, while others who

are unable to do this may be more affected by the change. If the department does not make amendments to adjust how tags go to guides there effectively would be no Guide and Outfitter Tags available for 2026 eastern Oregon deer hunts.

Lastly, application fees for controlled hunts are increasing from \$6 per application to \$8, meaning with the \$2 license agent fee, that applying for a controlled hunt in 2026 will cost \$10 per application. This will affect all people who apply for controlled hunts. The application cost will increase by \$1 again in 2028 and by an additional \$1 in 2030. The controlled hunt application fee increase is needed to support the department's programs into the future and takes into consideration inflation in the cost of doing business since this administratively set fee was last changed for the 2010 license year.

(2) Effect on Small Businesses: (a) Estimate the number and type of small businesses subject to the rule(s);

The types of business subject to the rule are primarily those that supply goods or services to hunters. These may include taxidermy services, hunting guides, private hunting preserve operators, food and beverage stores, gasoline stations, sporting goods stores, general merchandise stores, accommodation businesses, food services and drinking places. Big game hunting occurs in myriad locations throughout the state and thus the number of small businesses subject to the rule cannot be estimated.

Specific to the 2026 regulations, landowners as well as outfitters and guides who apply for mule deer hunting in eastern Oregon may be impacted by the shift to Deer Hunt Areas, which effectively modifies hunting boundaries and hunt names.

The department is unable to estimate the number of landowners who will be affected as the agency does not know exactly how many tags would be affected and if affected, whether landowners would lose or gain revenue from selling those tags.

Regarding outfitter and guides, the department has 61 individual outfitters approved in the agency licensing system to apply for tags through this program. However, often multiple guides will work for a single business. It is estimated there are approximately 15-20 hunting guide businesses in Oregon. The number of impacted guiding businesses would also be further restricted to those who offer services for deer hunting in eastern Oregon.

(b) Describe the expected reporting, recordkeeping and administrative activities and cost required to comply with the rule(s);

These types of compliance costs are not anticipated.

(c) Estimate the cost of professional services, equipment supplies, labor and increased administration required to comply with the rule(s). These types of compliance costs are not anticipated. Amendments regarding the prohibited use of any electronic scopes that receive information and infrared/thermal devices further clarify the type of equipment that is banned in the department's current hunting regulations. This provides direction for hunters not to spend money on devices that are not legal to hunt with in Oregon.

DESCRIBE HOW SMALL BUSINESSES WERE INVOLVED IN THE DEVELOPMENT OF THESE RULE(S):

The Department conducted a Big Game Regulation Review Project and has pursued efforts to update the regulations to clarify regulatory language and provide fair and consistent opportunity while ensuring biological objectives are met. Public input to help inform these changes includes an online public forum conducted in 2020, and 2019 and 2020 surveys of over 4,000 randomly selected resident deer and elk hunters. In July 2025 the Department hosted four regionally focused online public meetings with an opportunity for participants to submit questions and comments. Recordings of these public meetings were available for viewing on the Department webpage.

During the 2025-27 budget development process, the department engaged impacted stakeholder groups through two public meetings, multiple in person meetings with impacted parties and representative stakeholder groups. The proposed 2026, 2028, and 2030 fee increases on a subset of hunting tags and youth license were adjusted to incorporate feedback received from hunters and hunting groups. Hunting related fees for 2026 were established in statute through the legislative process which included public hearings and opportunities for both written and oral comment.

WAS AN ADMINISTRATIVE RULE ADVISORY COMMITTEE CONSULTED? NO IF NOT, WHY NOT?

No, the Department utilizes several other forms of public outreach to gather input into draft rules. These rules are amended annually to administer an existing program. While interested and affected persons are generally aware of this rulemaking schedule, the Department issues a news release describing where draft proposals are posted online as well as public meeting schedules.

Application Eligibility and Procedures ¶¶

- (1)(a) An applicant for game mammal controlled hunts shall have a current adult hunting license or youth combination license. ¶¶
- (b) Licenses are nonrefundable, whether or not an applicant is successful in the drawing. ¶¶
- (2)(a) A valid controlled hunt application is required to participate in a controlled hunt drawing. The purchase price of the application ~~shall be a nonrefundable fee of \$6.00 per game mammal for each game mammal hunt series shall be a nonrefundable fee as listed below:~~ ¶¶
- (A) For license years 2026 and 2027, \$8.00 per application plus a nonrefundable \$2.00 license agent fee. ¶¶

(1) To hunt with a centerfire rifle during the deer and elk seasons and dates in the Wildlife Management Units listed in Table 1 below without a used or unused deer, elk, pronghorn, antelope, bighorn sheep, or Rocky Mountain goat tag valid for the dates and area being hunted. ¶¶

Table 1. Wildlife Management Units and dates requiring a valid deer, elk, pronghorn antelope, bighorn sheep, or Rocky Mountain goat tag to hunt with a centerfire rifle. (See attached table)¶¶

(2) To hunt on any refuge closed by the state or federal government.¶¶

(3) To hunt within the corporate limits of any city or town, public park or cemetery, or on any campus or grounds of a public school, college, or university or from a public road, road right-of-way, or railroad right-of-way.¶¶

(4) Notwithstanding section (3) of this rule, controlled antlerless elk hunts are permitted within the south city limits of Seaside if the herd should become a serious problem.¶¶

(5) To hunt in any Safety Zones created and posted by the Department.¶¶

RULE SUMMARY: Set hunting season regulations and controlled hunt tag numbers for 2026 game mammal seasons including licensing and application requirements, and regulation changes to cooperative travel management areas. The proposed rules incorporate information gathered during the Big Game Hunt Review Process, which was intended to result in consistent and simpler big game seasons with opportunity allocated fairly and consistent with hunter preferences.

Additional amendments relating to electronic scope devices and electronic tagging (e-tagging) clarify the language of the existing rules. For 2026, there will be a transition from Wildlife Management Units (WMU) to Deer Hunt Areas in eastern Oregon. These changes are being proposed to better align hunting boundaries with deer populations and will necessitate new solutions to how landowners and guides are allocated tags in this region.

Tag Limitations ¶

- (1) Tags issued in the above described allocation process are for nonresident hunters only. Outfitter and Guides and their immediate families (as described in OAR 635-045-0002) or their employees are not eligible to receive or use tags described in this allocation process for personal use, when that Outfitter and Guide made the original application.¶
- (2) Tags issued under this allocation process are valid only when the hunter is being guided by the Outfitter and Guide or their employee who made the original application as described above in an "Outfitter and Guide Hunt" as defined in 635-045-0002. ¶
- (3) Tags shall not be transferred among Outfitter and Guides or among hunters and the Outfitter and Guide who drew the tag must have a federally issued special use permit for the area where they are guiding when guiding on federal land.¶
- (4) Tags issued to an Outfitter and Guide will be revoked if at any time the Marine Board revokes or denies a registration or certification. Refunds for tags will be issued to Outfitter and Guides only.¶
- (5) When the commission reduces allocated tags, refunds for tags only will be issued to Outfitter and Guides who were not selected in the reallocation process.

Remaining Tags ¶¶

- (1) Any remaining Outfitter and Guide tags not sold on or before March 31st will become available on a first-come, first-serve basis. The Department will publish a list of available tags two business days after March 31st.¶¶
- (2) First-come, first-serve tags will become available for purchase starting at 8:00 AM on the third business day after March 31st and ending at 5:00 PM on April 15th. Any applications received prior to 8:00 AM on the third business day after March 31st will not be accepted.¶¶
- (3) Up to five first-come, first-serve tags can be sold to outfitters and guides for unnamed clients.¶¶
- (a) The non-refundable tag fee for unnamed client tags is ~~\$565.00 (plus a \$10.00 license agent fee) for deer and \$838.00 (plus a \$10.00 license agent fee) for elk~~ the same as stipulated for Guide Tag - Deer and Guide Tag - Elk in Oregon Revised Statue 497.061.¶¶
- (b) The deadline to identify a hunter for tags sold with unnamed clients is one week before the hunt begins.¶¶
- (4) An unlimited number of first-come, first-serve tags can be sold to an outfitter or guide when the client is identified.¶¶
- (5) Any unsold Outfitter and Guide Tags remaining after 5:00 PM on April 15th will be included in the June public controlled hunt drawing.
