I have very serious concerns about the proposed changes to the deer units in eastern Oregon. My family and I ranch in Grant County and care deeply about the land and wildlife it supports. The new Aldrich unit affects us particularly hard as we currently own property in the Ochoco, Silvies and Murderers creek units. All the land we have saved our money to buy falls into the new Aldrich unit. The proposed new units are not handling the LOP tags correctly. All the LOP tags that are being removed from the Silvies and Ochoco units should be added to the existing Murderers Creek LOP count. Penalizing land owners by reducing LOP tags is not right, fair, or equitable. By reducing LOP tags you will not be giving public lands hunters one additional opportunity to harvest a buck. I strongly urge you to rethink this change and would encourage you to do the right thing for the citizens of the state of Oregon. It feels like eastern Oregon is getting disregarded by Salem. Don't reduce the LOP tags. Thank you.

RE: 2026 Oregon Big Game Regulations Proposals

The Oregon Hunters Association (OHA) is supportive of the 2026 Big Game Hunt proposals. OHA supports the thoughtful addition of hunting restrictions around bonafide, purpose-built wildlife crossing structures, and specifically, OHA supports the 500-foot buffer distance for these proposed restrictions. As OHA, ODFW and various other partners continue to work toward the implementation of additional safe wildlife crossings across the state, this new rule will need to be updated to include those crossing structures (i.e., Interstate 5 Mariposa crossing).

Comments specific to mule deer hunt change proposals for 2026

The proposed mule deer hunt changes are likely the most significant changes to hunting in Oregon since the controlled hunt system was implemented. OHA understands the need to transition hunting and hunter harvest to the herd range scale for management purposes. However, OHA remains concerned over the transition process and communications. While ODFW attempted to share this significant proposed change with the hunting community, many mule deer hunters will likely be surprised when they look at the 2026 Big Game Hunting synopsis.

OHA offers the following points around this change:

- OHA supports splitting out white-tailed deer tags where they and mule deer overlap
- The social aspect and hunter understanding of the new hunt units will be difficult
- Transition management:
 - Tag allocation OHA supports reducing tag numbers to address hunter crowding in areas where multiple units have been combined
 - This change affects management of both mule deer and hunters and needs to be monitored closely over time
- ODFW must monitor this change closely; a post season detailed review should be conducted (after the 2026 season) by district staff and division staff to assess:
 - o If tag numbers in need of adjustment
 - o Impacts of hunter distribution
 - Population management of deer
 - Refining hunt units if necessary
- The commission and hunters should see an update on initial findings of this review before the 2027 season

OHA commends the department for its review of the controlled archery hunt system in eastern Oregon. These types of reviews are necessary and important elements of species management and alignment of our hunting opportunities.

Re: Deer poaching on private property

Dear Ms. Wahl,

As you can see from the enclosed photograph, this buck deer was poached (my best guess is that it occurred around August 27th after being discovered on August 29th). My wife and I saw this buck running with four others in this meadow on the High Izee Ranch on August 22nd and when we saw the group again on August 31st, this poached buck was missing. The group was easy to identify by sight: 4x3 spike on side 3 points on other velvet, one broken horn buck with lone 3 point, a smaller 4x4, and this big 4x5 buck, which was missing. The group of bucks have been hanging around in the same area for some time.

There was more road traffic opening weekend of bow deer and elk season. Poaching will continue to happen more often when you combine the Ochoco and Silvies units into one big Aldridge unit. More traffic will occur and there aren't more deer out there, in fact, there are less. The last five years the population has reduced from around 200 to closer to 50 on our property alone. This tactic won't improve deer populations. Predators are the issue.

I strongly encourage you to talk to your game biologists that study the loss of deer population to predators but also talk to the people who live in the field, ranchers, state and federal game predatory contractors that are your trappers, hunters, outside-ODFW biologists, field representatives, Rocky Mountain Elk Foundation, Oregon Hunters Association, and Mule Deer Foundation. They will also verify what is happening to our deer population.

How many cougar and coyote sightings have there been in the cities? Just last week a cougar was sighted several times in Corvallis.

I encourage you to be proactive. Don't combine Ochoco and Silvies units into the one big Aldridge unit, taking away tags from landowners. It seems like you are masking the real problem: predators. Save the deer and elk populations.

- 1. Mountain lion/black bear/ wolf population are excessively high and are have a very large impact on the conservation of the deer/elk/BHsheep/mountain goat population.
- 2. Poaching of black bear and mountain lion is unreasonably high. Criminals are literally shooting and leaving the carcasses of these animals. This is not hunting and it is not ethical. Also leaves the information of the predator population lacking true information. This is a waste of our natural resources.

My resolve for these 2 issues that I believe would have positive impact and be mutually beneficial to all Oregon citizens is to consider offering a special (1) preference point to either deer or elk preference point (1) per year max for a predator harvested ever year. Subject: Reduction in landowner preference tags

I am writing about a proposal to reduce landowner preference tags for mule deer, specifically in the Silvies or new Juniper/Silvies Unit. I've heard indirectly about this possibility, and I wanted to express my concern over such a proposal from the standpoint of habitat improvement and healthy wildlife populations.

As a Research Leader with the USDA-Agricultural Research Service I spent 25 years managing a 7-scientist-research unit that focused on rangeland ecology and management. Our research covered juniper woodlands, sagebrush steppe, riparian ecosystems, and flood meadows. Many of these efforts had a goal of improving land health, productivity, and habitat value. We often worked with wildlife biologists, and we were heavily involved in many of the sage-grouse planning efforts now in place. I retired in 2015 and have been a private consultant since that time.

A significant part of my work has been to advise landowners on the best management practices for land restoration, resilience, and habitat value. Several of the folks I work with bought ranches specifically for hunting and maintain a livestock operation as a secondary pursuit. These folks use public programs administered by USDA-NRCS and various watershed councils, but they also put a significant amount of their own money into habitat improvement. They have a strong land ethic and feel a personal tie to the wildlife populations on their land. I worry that reducing access to landowner preference tags will take away an incentive these folks have for land improvement, with negative consequences for associated wildlife populations,

I would be happy to discuss this topic with anyone who has an interest.
