

Statement of Interest

1) Experience and knowledge of hunting *or* knowledge and breadth of experience in the agriculture or forestry industries.

I'm a lifelong Oregonian with over 30 years of hunting and fishing experience, primarily in the mid and northern Oregon Coast Range. Over the past four years, I've had the privilege of serving on the board of the Access and Habitat Program, which has significantly deepened my understanding of public-private partnerships across the state. Through this role, I've gained valuable insight into the relationship-building necessary to create mutually beneficial outcomes for both landowners and the hunting community. I've spent considerable time on the ground in the mid-coast and north-coast travel management areas, as well as in Access and Habitat-funded travel management areas on the east side of the state—such as the Norgard Travel Management Area in the Sled Springs unit. My professional background also aligns closely with this work: as a policy expert on wildlife and aquatic connectivity issues across the Intermountain West, I engage directly with the agricultural and forest sectors. I've led and participated in numerous collaborative stakeholder groups focused on developing practical, common-sense solutions to complex issues affecting national forests, private timberlands, agricultural lands, and public and private landscapes. My approach centers on meeting people where they are, fostering strong relationships, and building trust to achieve shared goals.

In addition to my role with the A&H Board, I currently serve on the board of the Oregon Chapter of Backcountry Hunters and Anglers, and have been an active member since the organization's inception in the state. I'm also a member of the Northwest Guides and Anglers Association and the Northwest Steelheaders. My involvement with these organizations has given me a well-rounded perspective on the key habitat issues we face in Oregon—both terrestrial and aquatic. In my professional role, I work closely with state wildlife agencies across the Intermountain West, including in Nevada, Montana, Idaho, and Utah. This work keeps me deeply engaged with habitat challenges throughout the region. While some issues are unique to individual states, many reflect broader trends and pressures that span multiple jurisdictions. This regional perspective helps inform my approach to conservation and policy work in Oregon. In most of these states I have led efforts working closely with agency leadership to secure new administrative and legislative policies for the benefit of fish and wildlife.

In addition to my role on the A & H Board, I've proudly served as an active board member of Backcountry Hunters and Anglers for the past decade. In my role as a Senior Officer with The Pew Charitable Trusts, I help oversee significant grant funding to hunter, angler, and conservation organizations across the West. This work involves close collaboration with organizational leadership to advance targeted policy outcomes that support habitat conservation and benefit fish and wildlife populations throughout the region.

4) Leadership and experience on *or* with councils, boards, commission, and legislature.

Over the past five years, I've authored dozens of pieces of legislation focused primarily on terrestrial connectivity and securing funding for state fish and wildlife agencies to implement habitat restoration, wildlife corridor initiatives, and wildlife crossing infrastructure. In addition to drafting policy, I've led comprehensive campaign efforts to advance these bills—identifying legislative champions, collaborating closely with governors' offices and agency leadership, and building strong coalitions with conservation organizations as well as hunter and angler groups. These coordinated efforts have been instrumental in getting key legislation passed and signed into law.

5) Experience working with and/or representing the public.

Many of the hunter, angler, sporting, and conservation groups I work with have strong, engaged membership bases. Effectively engaging these members is essential—not only for shaping organizational priorities, but also for generating meaningful support around specific policy issues. In my work with Backcountry Hunters and Anglers, for example, our membership directly influences the issues we take on. Whether in my role as a board member or as a coalition leader, connecting with members and activating grassroots support is a core strategy for advancing shared goals and achieving policy success.

6) Ability/interest in working collaboratively with others.

Over the past four years as a board member with the Access and Habitat Program, the most rewarding aspect of my work has been the opportunity to collaborate—not only with fellow board members and Oregon Department of Fish and Wildlife staff, but most notably with the partners and landowners who utilize the program across the state. These relationships are the foundation of the program's success, and I'm deeply committed to continuing to build and strengthen them in the years ahead.

7) Participation in the Access and Habitat program.

Although I am not a direct participant in the Access and Habitat Program as a landowner, I have benefited from many of the partnerships it has fostered across the state by utilizing many of the acres the program has ensured remain open to the public. In my current role with The Pew Charitable Trusts, we advocate for programs like Access and Habitat—many of which are housed in the Farm Bill—and work to ensure they receive appropriate funding to continue into the future. Our efforts focus on highlighting success stories from across the West that demonstrate why these programs must be reauthorized and adequately funded.

1) Experience and knowledge of hunting *or* knowledge and breadth of experience in the agriculture or forestry industries.

Hunting has been an incredibly important part of my life for the past 30+ years, and if you consider that my dad and grandpa originally got me into hunting, the impact extends beyond my own lifetime. Hunting to me is a connection to the landscape, it is a family tradition, and it demonstrates a values system that's rooted in stewardship and respect for all the wild places that Oregon has to offer. Over the last 30 years I've hunted upland birds, waterfowl, turkeys, bears, deer, and elk all throughout Oregon's public lands, as well as private lands where access was granted through permission or longstanding friendships. This mix has helped me appreciate the vital role both public access and private stewardship play in maintaining Oregon's diverse landscape and wildlife health.

I've been returning to many of the same areas since childhood – for upland, my family has hunted the same stretch of the Malheur River for 50 years or more. The long-term, lived-in perspective, combined with my professional experience as a leader, gives me a unique lens that I believe would be valuable on the Commission.

Although I do not work directly in agriculture or forestry, I regularly engage with these sectors in meaningful ways. My brother works for Sustainable Northwest – a local organization that partners with communities throughout the Northwest on projects that promote smart water use, clean energy, and healthy forests, farms, and ranches – and our conversations are often dominated by hunting, habitat, and what we can do to remain involved. Through these conversations and

experiences I've seen what the negative consequences can be to our hunting landscape when lands are not managed well: fires, habitat degradation, and flooding.

2) Involvement in sportsman/hunter/conservation organizations or experience with fish & wildlife resource management issues

My experience with fish and wildlife resource management has been shaped by the many years that I've spent hunting and fishing across public and private lands in Oregon, paying close attention to how access and habitat quality can impact hunters' experiences over time. While I am eager to be involved and learn more in this space, I believe my experience has made me highly attuned to the importance of access rights and having a diverse mix of public and private lands available to hunters and anglers alike.

3) Leadership in sportsman/hunter/conservation organizations or involvement in agriculture or forest industry organizations.

While I don't hold a formal leadership role within a hunting or conservation organization, I have been an active member of Backcountry Hunters & Anglers (BHA) and consistently engage in advocacy for public lands and wildlife access. I regularly submit public comments and write to elected officials to ensure that the perspective of everyday hunters — those who rely on and respect public lands — is part of the conversation. My engagement with BHA reflects my belief that hunters should be active stewards and

vocal participants in shaping the future of our wild spaces. This complements a lifetime of hands-on experience hunting across Oregon's landscapes, from Sauvie Island to the breaks of the Grande Ronde.

4) Leadership and experience on or with councils, boards, commission, and legislature.

As a senior leader within a \$100M organization, I have experience working closely with our own Board of Partners. In that capacity, I regularly help to shape the strategic vision, navigate complex decisions, and steward resources to support our long-term goals. Most importantly, this work has deepened my understanding of how a board functions most effectively – as vehicles for vision, accountability, and collaboration. Through this experience I have sharpened my ability to communicate, listen, and lead with honesty and transparency. Beyond my professional role, I also served on the Ambassador Board for De La Salle North Catholic High School (DLSNC) in Portland, Oregon. This experience was extremely meaningful as I had the opportunity to establish partnerships with local Portland-Metro businesses who supported DLSNC's Corporate Work Study Program, providing students from under-resourced backgrounds with the opportunity to work in local companies and gain real-world experience. That exposure helped open doors for the students and helped to strengthen the ties between the school and the business community. Each of these experiences has reinforced the importance of servant leadership – showing up not for recognition, but to enable and support the success of others.

5) Experience working with and/or representing the public.

My commitment to public engagement is best reflected in the work that I did with De La Salle North Catholic High School, where I worked with fellow business leaders to expand the school's Corporate Work Study Program. What is unique about this program is that students attend a normal classroom four days a week, and on the fifth day they work for businesses in the local community. In return for the work that students are doing the businesses pay an annual contract, and this is where a material part of the school's funding comes from. In many instances, students come from underserved communities, which makes this hands-on learning opportunity especially valuable. These experiences have taught me how to work across sectors and communicate with empathy and clarity. Being an advisory Board member requires thoughtful outreach, relationship building, and aligning different priorities toward a common goal. Through this I learned that by volunteering we were making a meaningful investment in the lives of DLSNC students.

6) Ability/interest in working collaboratively with others.

Through my work and personal experiences, I've learned that meaningful progress rarely happens in isolation. At its foundation, it requires trust — and only from that foundation can you begin to work through conflict and garner commitment. When I first started in my role as the Chief Financial Officer, I came in young, bullish, and excited to make change. I started by looking at processes, and right away I believed I saw ways to build a better mousetrap. But as I went to make changes across the organization, I was met with trepidation and resistance.

Through self-reflection, I realized that to be truly effective in my role, I first needed a process requiring time, intention, and relationship-building. This was a different kind of hard work than I was used to. It

required discipline, a willingness to listen, and genuine curiosity. As I traveled between offices and spent time with different people, I quickly began to understand the value of trust — how it opened doors, reduced resistance, and created the space for real collaboration. Since learning that lesson, I've made it a priority to lead by building relationships and investing in mutual trust — because without it, true collaboration simply isn't possible.

7) Participation in the Access and Habitat program.

My participation in the Access and Habitat program relates to time that I've spent in the field accessing private timberland near Tillamook and Cannon Beach. One trip stands out, as it was one of the first hunts that my brother and I were able to go on together that year. For one reason or another, our upland season opener didn't work out, and we both spent September chasing elk in different areas of the state. Excited to go look for blacktail, we accessed timberlands just outside of Tillamook and hit the ground hiking. Although the day didn't end with a punched tag, we saw several blacktail deer and marked our OnX maps for future outings.

Despite coming home empty-handed that day, I vividly remember talking to my brother on our drive home and discussing how fortunate we were to have access to lands through the A&H program. My belief is that these programs don't just provide physical access — they help to uphold a longstanding tradition, and they help deepen relationships with the land, as well as the ones that we share it with.

8) Ability to foster positive relations between landowners, and ODFW.

I've been incredibly fortunate to grow up hunting and to have had the opportunity to hunt across both public and private lands. During my childhood, this often looked like knocking on the doors of farmers outside of Ontario, asking for permission to pursue the roosters we'd seen scurry into the ditch bank as we drove by that morning. Amazingly, some of them said yes, and we've had decade-long friendships since — trading phone calls throughout the year and always receiving one another's Christmas cards.

As I grew older, some of my childhood friendships evolved into hunting buddies, and with that came access to private lands for hunting and fishing. At the same time, I continue to spend a great deal of my season on public land — glassing for bears in northeastern or southern Oregon, calling for turkeys in the Umatilla National Forest, or chasing my dog through the Deschutes or John Day canyons for chukar. Through this wide range of experiences, I've come to appreciate the great value in having a diverse landscape that spans both public and private lands.

These dual experiences have also helped me recognize potential tensions — but more importantly, I see the shared interests that exist between private landowners, the public, and agencies like ODFW. Because of this experience, I believe I am exceptionally well positioned to foster relationships between landowners and ODFW. I understand the concerns that landowners and the public have — about access, regulation, and habitat — and I believe that through relationship-building, we can unlock mutual benefits through programs like the Access and Habitat Program or simply through trust and transparent communication.
