

Aldrich Herd (AD)

AD01: 66% public land. Beginning at John Day; east on US Hwy 26 to Prairie City, southeast on Co Rd 62 to FR 13, southeast on FR 13 to FR 16, southwest on FR 16 to Seneca, south on US Hwy 395 to FR 3140, west on FR 3140 to Silvies Rvr, southwest on Silvies Rvr to Emigrant Cr, west on Emigrant Cr to FR 47/Hines Logging Rd, south on FR 47/Hines Logging Rd to FR43, west on FR 43 to FR 4370, west on FR 4370 to FR 41, northwest on FR 41 to Swamp Cr Ln, northwest on Swamp Cr Ln to Weberg Rd, northwest on Weberg Rd to Co Rd 112, northwest on Co Rd 112 to Co Rd 113, northeast on Co Rd 113 to Wolf Cr Rd, north on Wolf Cr Rd to FR 42, north on Buck Point Rd/FR 12 to US Hwy 26, east on US Hwy 26 to John Day, point of beginning.

DO01: 73% public lands. Beginning at Hwy 395 at California state line; north on Hwy 395 to Fort Bidwell-Warner Valley Rd north of Abert Lk (Lake Co Rd 3-10, Hogback Rd); south/southeast on Fort Bidwell-Warner Valley Rd to Flagstaff Lk Rd (Lake Co Rd 3-11); east on Flagstaff Lk Rd to Hart Mtn NAR boundary; south/southeast on Hart Mtn NAR boundary to Shirk Ranch Rd (BLM Rd 6106-00); south on Shirk Ranch Rd to Hwy 140; east/southeast on Hwy 140 to Nevada state line; west along Nevada and California state lines, point of beginning.

DO02: 99% public lands. All lands within the Hart Mountain National Antelope Refuge boundary.

Deschutes Herd (DE)

DE01: 74% public lands. Beginning at Bend; southwest on US Hwy 97 to S Century Dr at MP 153; west on S Century Dr to intersection with Spring Rvr Rd/NF-40; west on Spring Rvr Rd/NF-40 to Deschutes Rvr crossing at Harper Bridge; south (upstream) on the main channel of the Deschutes Rvr to the Wickiup Reservoir Dam; northwest on NF 4260 along Wickiup Dam to S Century Dr/NF 42; west on S Century

Devils Garden Herd (DG)

Beginning in Riley. southwest on Hwy 395 to Christmas Valley Hwy (Lake Co Rd 5-14); west on Christmas Valley Hwy (Lake Co Rd 5-14) to junction with Millican Rd (Lake Co Rd 5-14C), 2 mi east of Christmas Valley; north on Millican Rd (Lake Co Rd 5-14C) to intersection of Sink Rd (Lake Co Rd 5-12B); west on Sink Rd (Lake Co Rd 5-12B) to junction of Millican Rd (Lake Co Rd 5-12D); north on Millican Rd (Lake Co Rd 5-12D) to Deschutes Co line; north on Fox Butte/Newt Morris Rd to Hwy 20; east on Hwy 20 to Riley, point of beginning. (Maps: Lakeview / Prineville / Vale BLM)

DG02: 77% public lands. Beginning at Redmond; east on State Hwy 126 to Prineville; southeast on State Hwy 27 to US Hwy 20; west on Hwy 20 to Newt Morris Rd/Fox Butte Rd; south on Fox Butte Rd to Lake Co line; south on Lake Co Rd 5-12D to intersection of Sink Rd (Lake Co Rd 5-12B); east on Sink Rd (Lake Co Rd 5-12B) to intersection of Millican Rd (Lake Co Rd 5-14C); south on Millican Rd (Lake Co Rd 5-14C) to junction of Christmas Valley Hwy (Lake Co Rd 5-14); west on Christmas Valley Hwy (Lake Co Rd 5-14) 13 mi to junction with Fort Rock Rd (Lake Co Rd 5-10); 22 mi north and west on Fort Rock Rd (Lake Co Rd 5-10) to State Hwy 31; northwest on Hwy 31 to NF-2516; south on NF-2516 to NF-9775; west on NF-9775 to US Hwy 97; south on Hwy 97 to Crescent; west on Crescent Cutoff Rd (Klamath Co Rd 61) to State Hwy 58; northwest on Hwy 58 to Pacific Crest Trail (PCT); north on PCT to NF-4290 near Charlton Lk, east on NF-4290 to Cascade Lakes Scenic Byway; east on S Century Dr/ NF-42 to NF-4260; south on NF-4260 and then east along Wickiup Dam to the Deschutes Rvr; north (downstream) on the main channel of the Deschutes Rvr to the crossing at Harper Bridge with Spring Rvr Rd/ NF-40; east on Spring Rvr Rd/ NF-40 to intersection with S Century Dr; east on S Century Dr to US Hwy 97; northeast on US Hwy 97 to Redmond, point of beginning. DG03: 71% public land. DG04: 66% public land. Beginning at Silver Lake; southeast on State Hwy 31 to NF 29; west on NF 29 to NF 28; northwest on NF 28 to NF 30; west on NF 30 to Sycan Rvr at Pikes Crossing; downstream north and southwest on Sycan Rvr to NF 4400-830; west on NF 4400-830 to NF 44; northwest on NF 44 to NF 46; west on NF 46 to Williamson Rvr Rd; west on Williamson Rvr Rd to NF 4526; north on NF 4526 to NF 43 (Kirk Rd); northeast on NF 43 (Kirk Rd) to Silver Lk Rd; east on Silver Lk Rd (named Bear Flat Rd in Lake Co) to State Hwy 31; east on State Hwy 31 to Silver Lake, point of beginning.

Elkhorn Herd (EH)

EH01: 46% public lands. Beginning at junction of Interstate 84 and State Hwy 86; southeast on I-84 to Malheur Line Rd overpass; west on Malheur Line Rd to Huntington Rd; west on Huntington Rd to Willow Cr Rd; northwest on Willow Cr Rd to Us Hwy 26 at Ironside; northwest on US Hwy 26 to Rouse Ln; northeast on Rouse Ln to Rice Rd; north on Rice Rd to N. Fork Burnt Rvr Rd (Co rd. 529); north on N. Fork Burnt Rvr Rd to State Hwy 7; west on State Hwy 7 to Greenhorn Rd; northwest on Greenhorn Rd to NFD Rd 1305; north on NFD 1305 to NFD 013; north on NFD 013 to NFD 10; north on NFD10 to NFD 73; north on NFD 73 to Anthony Lks Hwy; northeast on Anthony Lks Hwy to Ellis Rd; north on Ellis Rd to North Powder Rvr Ln; east on North Powder Rvr Ln to I-84 at North Powder; southeast on I-84 to, point of beginning.

EH02: 64% public lands. Beginning on I-84 at State Hwy 82 at La Grande; southeast on I-84 to North Powder; west on N Powder Rvr Ln to Ellis Rd; south on Ellis Rd to Anthony Lks Hwy; west on Anthony Lks Hwy to NFD 73; west on NFD 73 to NFD 52 Granite-Ukiah Rd; northwest on Granite-Ukiah Rd NFD 52 to Tower Mt Rd 5226; east and north on Tower Mt Rd 5226 past Tower Mt and Frazier Forest Camp to State Hwy 244 (FR 59); east on Hwy 244 (FR 59) to FR 5900230 at Four Corners Forest Camp; north on Rd 5900230 to 2100040, north on Rd 2100040 to FR 21; north on 21 to FR 2135; northeast on 2135 to FR 2135400; northeast on FR 2135400 to Kamela: east on Summit Rd to I-84; southeast on I-84 to Hwy 82, point of beginning.

Fox Herd (FX)

FX01: 82% public lands. Beginning at Ukiah east on State Hwy 244 to Tower Mt Rd/FR 5226, south on Tower Mt Rd/FR 5226 past Frazier

FR 52, southeast on Granite-Ukiah Rd/FR 52 to FR 73, south on FR 73 to FR 10, west on FR 10 to FR 13, south on FR 13 to FR 1305, south on FR 1305 to Greenhorn Rd, southeast on Greenhorn Rd to State Hwy 7, east on State Hwy 7 to N. Fork Burnt Rvr Rd, south on to N. Fork Burnt Rvr Rd to Rice Rd, south on Rice Rd to Rouse Ln, southwest on Rouse Ln to US Hwy 26, northwest on US Hwy 26 to State Hwy 7, north on State Hwy 7 to Co Rd 20, northwest on Co Rd 20 to US Hwy 395, west on the Middle Fork John Day Rvr to the confluence of the N Fork John Day Rvr, northeast on the N Fork John Day Rvr to the confluence of Camas Creek, follow Camas Creek northeast to Hwy 395, north on US Hwy 395 to State Hwy 244, east on State Hwy 244 to Ukiah, point of beginning.

FX02: 41% public lands. Beginning at John Day east on US Hwy 26 to Prairie City, southeast on Co Rd 62 to FR 13, southeast on FR 13 to FR 1370, north on FR 1370 to FR 2652; north on FR 2652 to FR 6005; northeast on FR 6005 to the junction with S Burnt Rvr Ln; northeast on S Burnt Rvr Ln to the town of Unity and US Hwy 26, northwest on US Hwy 26 to State Hwy 7, north on State Hwy 7 to Co Rd 20, northwest on Co Rd 20 to US Hwy 395, west on the Middle Fork John Day Rvr to the confluence of the N Fork John Day Rvr, southwest on N Fork John Day Rvr to State Hwy 19, south on State Hwy 19 to US Hwy 26, east on US Hwy 26 to John Day, point of beginning.

FX03: 46% public lands. Starting in Mitchell head east on Hwy 26 until you reach Hwy 19. Travel north on Hwy 19 to the North Fork John Day Rvr, follow the North Fork John Day Rvr north and east to the confluence of Camas Cr, follow Camas Cr north to Hwy 395. Head north on Hwy 395 to the intersection with FR 53. Follow FR 53 until vou reach the Umatilla National Forest boundary. then continue north and west along the northern boundary of the Umatilla National Forest to Kinzua Rd. Travel west on Kinzua Rd to Hwy 19. Head south on Hwy 19 to the intersection with Hwy 207, south on Hwy 207 back to Mitchell.

Helix Herd (HX)

HX01: 9% public land. Starting in Arlington, follow the Columbia Rvr east to the Oregon-Washington state line. West along the state line until you reach Hwy 11, south and west on Hwy 11 until it meets Interstate 84. Follow I-84 west until you reach Hwy 207. Take Hwy 207 south to Hwy 74 in Lexington. Continue northwest on Hwy 74 to McNab Lane. Head west on McNab/Baseline Rd until intersection with Hwy 19. North on Hwy 19 back to Arlington.

Jackknife Herd (JK)

JK01:12% public lands. Beginning at the mouth of the Deschutes Rvr, head east along the Columbia Rvr to Arlington; south on Hwy 19 to Fossil; southwest on Hwy 218 to Antelope; southwest on OR-293 Antelope Hwy until reaching Hwy 97; north on Hwy 97 until reaching Hwy 197 and South Junction Rd; southwest on South Junction Rd until reaching the Deschutes Rvr at South Junction; downstream on the Deschutes Rvr until reaching the Columbia Rvr, point of beginning.

Juntura Herd (JT)

JT01: 50% public land. Beginning at Vale; southwest on US Hwy 20 to the North Fork Malheur Ryr near Juntura; north on the North Fork Malheur Rvr to the Little Malheur Rvr; north on the Little Malheur Rvr to Elk Flat Cr; west on Elk Flat Cr to FR 1370; north on FR 1370 to FR 2652; north on FR 2652 to FR 6005; northeast on FR 6005 to the junction with S Burnt Rvr Ln; northeast on S Burnt Rvr Ln to the town of Unity and US Hwy 26; southeast on Hwy 26 to Ironside; east on Willow Cr Rd to Huntington Junction; east on Huntington Junction Rd/Malheur Line Rd (Durbin Cr) to I-84; southeast on I-84 to Birch Cr near Farewell Bend; east on Birch Cr to Snake Rvr; southeast along Snake Rvr to Nyssa; north on US Hwy 20/OR Hwy 201 to Cairo Junction; and west on US Hwy 20 to Vale, point of beginning.

JT02: 73% public land. Beginning at the junction of state Hwy 78 and Crane-Buchanan Rd (Harney Co Rd 312) near Crane; north on Crane-Buchanan Rd to US Hwy 20; east on Hwy 20 to Cairo Junction; south on US Hwy 20/OR Hwy 201 to Oregon-Idaho State Line in Nyssa; south on Oregon-Idaho state line to the Owyhee Rvr; southwest on the Owyhee Rvr and Owyhee Reservoir to the Dry Cr Arm of Owyhee Reservoir; west on the Dry Cr Arm of Owyhee Reservoir and Dry Cr to Crowley Rd (Malheur Co Rd 585); southwest on Crowley Rd and Crowley-Riverside Rd (Malheur Co Rd 513) to OR Hwy 78; northwest on Hwy 78 to Crane-Buchanan Rd, point of beginning.

JT03: 59% public land. Beginning at the US Hwy 20/OR Hwy 78 Jct in Burns northeast on US Hwy 20 to US Hwy 395; north on Hwy 395 to Seneca; east on Logan Valley Co Rd (FR 16) to FR 13; north on FR 13 to FR 1370; northeast on FR 1370 to Elk Flat Cr; east on Elk Flat Cr to the Little Malheur Rvr; south on the Little Malheur Rvr to the North Fork Malheur Rvr; south on the North Fork Malheur Rvr to US Hwy 20; west on Hwy 20 to Crane-Buchanan Rd (Harney Co Rd 312); south on Crane-Buchanan Rd to state Hwy 78; south on Hwy 78 to Lava Bed Rd (Harney Co Rd 404); south and west on Lava Bed Rd to Sodhouse Ln (Harney Co Rd 405); west on Sodhouse Ln to state Hwy 205; north on Hwy 205 to state Hwy 78; west on Hwy 78 to US Hwy 20 in Burns, point of beginning.

Keno Herd (KE)

Beginning at Klamath Falls; south on US Hwy 97 to Oregon-California state line; west on state line to Copco Rd; north on Copco Rd to State Hwy 66; east on Hwy 66 to Jackson-Klamath Co line; north on Jackson-Klamath Co line to Dead Indian Rd; northeast on Dead Indian Rd to FR 3601; north on 3601 to State Hwy 140; east on Hwy 140 to FR 3661; north on 3661 to Fourmile Lk; northwest on Forest Trail 993 to Pacific Crest Trail; north on Pacific Crest Trail to south boundary of Crater Lk NP; east on south boundary of Crater Lk NP to State Hwy 62; southeast on Hwy 62 to Hwy

97; south on Hwy 97 to Klamath Falls, point of beginning. (Maps: Winema NF)

Klamath Basin Herd (KB)

KB01: 56% public land. Beginning at Bly; west on State Hwy 140 to Beatty; north on Godowa Springs Rd to Sprague Rvr; west on Sprague Rvr one mile to Sycan Rvr; upstream north and east on Sycan Rvr to Pikes Crossing/NF 30; east on NF 30 to NF 28; southeast on NF 28 to NF 29; east on NF 29 to State Hwy 31; southeast on Hwy 31 to Valley Falls; south on US Hwy 395 to Oregon-California state line; west on state line to Lost Rvr; northwest on Lost Rvr to East Langell Valley Rd; north on East Langell Valley Rd to Gerber Rd; northeast on Gerber Rd to Bly, point of beginning.

KB02: 45% public land. Beginning at Klamath Falls; north on US Hwy 97 to State Hwy 62; northwest on State Hwy 62 to the south boundary of Crater Lk NP; east and north along the eastern boundary of Crater Lk NP to Sand Cr; east on Sand Cr to West Boundary Rd; east on West Boundary Rd one mile to US Hwy 97; east on Silver Lk Rd to NF 43 (Kirk Rd); south on NF 43 (Kirk Rd) to NF 4526; south on NF 4526 to Williamson Rvr Rd; east on Williamson Rvr Rd to NF 46; east on NF 46 to NF 44; southeast on NF 44 to NF 4400-830; east on NF 4400-830 to Sycan Rvr; downstream south on Sycan Rvr to Sprague Rvr; east on Sprague Rvr to Godowa Springs Rd north of Beatty; south on Godowa Springs Rd to State Hwy 140; east on State Hwy 140 to Bly; southwest on Gerber Rd to East Langell Valley Rd; south on East Langell Valley Rd to Lost Rvr; southeast on Lost Rvr to the Oregon-California state line; west on the Oregon-California state line to US Hwy 97; northeast on US Hwy 97 to Klamath Falls, point of beginning.

Mid-Columbia Herd (MC)

MC01: 37% public land. Beginning at the mouth of the Deschutes Rvr, head south along the Deschutes Rvr until reaching the Warm Springs Tribal Reservation boundary; west along the northern Warm Springs Tribal boundary until reaching Hwy 216 and Hwy 26; northwest on Hwy 26 until reaching Hwy 35; northeast on Hwy 35 to Hood River; east along the Columbia Rvr until reaching the Deschutes Rvr, point of beginning.

MCO2: 65% public land. Beginning at Hood Rvr; southwest on State Hwy 35 to Barlow Pass (Pacific Crest Trail); northwest on Pacific Crest Trail to Lolo Pass; northwest on Hood Rvr-Multnomah Co line to Columbia Rvr near Bonneville; east on Columbia Rvr to Hood Rvr, point of beginning.

North Blues Herd (NB)

NB01: 22% public lands. Beginning at Pendleton; southeast on I-84 to Mt. Emily exit; West on Co Rd to Kamela; southwest on FR 2135-400 to FR 2135; southwest on 2135 to FR 21; southwest on 21 to 2100-040; south on 2100-040 to FR 5900-230; south on 5900-230 to state Hwy 244 at Four Corners Forest Camp; west on State Hwy 244 to US Hwy 395; north on US Hwy 395 to Pendleton, point of beginning.

NB02: 0% public land. Beginning in Pendleton; south on Hwy 395 to FR 53; west on FR 53 to the Umatilla National Forest boundary; north and west along Umatilla National Forest boundary to Kinzua Rd; west on Kinzua Rd to Hwy 19; northwest on Hwy 19 to McNab/Baseline Rd; east on McNab/Baseline Rd to Hwy 74; southeast on Hwy 74 to Hwy 207 in Lexington; north and east on Hwy 207 to I-84; east on I-84, point of beginning.

Northeast Herd (NE)

NE01: 72% public lands. Beginning at confluence of Imnaha and Snake Rvr; southeast on Snake Rvr to Thirty-two Point Cr; southwest on Thirtytwo Point Cr to Summit Rd; southwest and northwest on Summit Rd to FR 3965; south on FR 3965 then west to Upper Crazyman Trailhead; south from Upper Crazyman Trailhead along Summit Ridge; west from Summit Ridge to FR 3962 (N Fork Dry Cr); southwest on N Fork Dry Cr and northwest on Dry Cr to Imnaha Rvr; south and west on Imnaha Rvr and S fork of Imnaha Rvr to Hawkins pass; northwest from Hawkins pass past Eagle Cap and Horton Pass; south from ridgeline past Frazier Pass, Needle Point, and Arrow Lk to Granite Butte; northwest on summit separating Big Minam and Catherine Cr drainages past Burger Butte and Meadow Mt to Cartwheel Ridge Trail 1907; west on Cartwheel Ridge Trail to Lodgepole Trail 1920; north on Lodge Pole Trail to Moss Springs campground; west on Mill Cr Rd to Cove; west on Hwy 237 to Island City; northeast on Hwy 82 to Elgin; northeast on Hwy 82 to Minam; south east on Hwy 82 to Joseph; northeast on Imnaha Hwy to Imnaha; north on Imnaha Rvr to confluence of Imnaha and Snake Rvr, point of beginning.

NEO3: 21% public lands. Beginning at Wallowa; west on State Hwy 82 to Elgin; northeast on Grande Ronde Rvr to Oregon-Washington state line; east along state line to Joseph Cr; southwest on Joseph Cr to Chesnimnus Cr; southeast on Chesnimnus Cr to Crow Cr Rd; south on Crow Cr Rd to Hwy 82; northwest on Hwy 82 to Wallowa, point of beginning. (Maps: Wallowa-Whitman NF, Vale BLM, ODF).

NE04: 73% public lands. Beginning at Troy; southwest on Grande Ronde Rvr to Elgin; northwest on State Hwy 204 to Tollgate; northeast on FR 64 to Oregon- Washington state line; east on state line to Grande Ronde Rvr; southwest on Grande Ronde Rvr to Troy, point of beginning. (Maps: Umatilla NF, ODF).
