#### **Department Financial Report**

The Commission Financial Report for the month closing October 31, 2025 is attached. This is the first report for the 25-27 biennium. For the period ending October 31, unrestricted cash finished with a balance of \$72.87 million and restricted cash finished with a balance of \$90.91 million. In sum, ODFW's total cash balance at state treasury is \$163.78 million. As a reminder, the unrestricted cash balance includes \$19 million in insurance proceeds for damages incurred during the 2020 wildfires.

### <u>Legislative Fiscal Office 5% Reduction Exercise</u>

Due to projected state General Fund and Lottery Fund shortfalls, the Legislative Fiscal Office (LFO) requested that all state agencies submit reduction options totaling 5% of agency allocations for General Fund, Lottery Fund, and Other Fund. ODFW approached this request utilizing a multipronged strategy to identify and prioritize potential reductions. ODFW's response to LFO's request includes utilization of accrued position vacancy savings, forecasted position vacancy savings from new positions authorized in the 2025 Legislative Session that have yet to be filled, targeted reductions to services and supplies, and positions listed on the agency's 2025-27 10% reduction list (revised to reflect mid 25-27 biennium figures).

ODFW joined other natural resource agencies at the Capital during interim Legislative Days in November and presented our response to the LFO request to the Joint Ways and Means Subcommittee on Natural Resources. Reduction options will be considered by the legislature for potential use this biennium, and any decisions made on options by the Legislature will occur during the 2026 Legislative Session that will occur February 2<sup>nd</sup> – March 9<sup>th</sup>, 2026. While Other Fund reduction options were required as a part of this exercise, the risks to these programs are minimal and we are not expecting any other fund impacts.

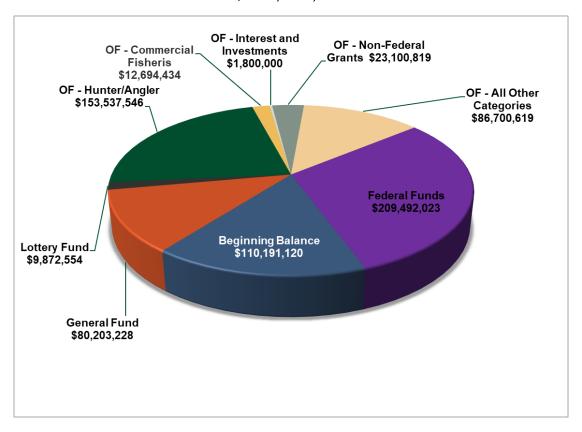
#### 2027-2029 Budget Development

Budget development is about to begin for the 2027-2029 biennium. The agency's development process will be initiated soon with a review of revenue and expenditure projections for the next biennium, and development of preliminary policy option packages.
