1 **Everyone Belongs Outdoors: Portland Pilot Project**

2 The Commission received an informational update on an ongoing project, “Relevant and  
3 Authentic Engagement for ODFW with Urban populations.” The Commission engaged in a

5 interviews with ODFW staff and residents of Portland that measure current awareness of

17 **Expenditure Report**

18 Ken Loffink, Chief Operating Officer

19 Ken provided the Commission with a report that as of December 31, 2025, ODFW held \$158.3  
20 million in cash at the state treasury, of which \$68.0 million was unrestricted (including \$17 million  
21 in wildfire-related insurance proceeds) and \$90.3 million was restricted. Agency revenues and  
22 expenditures for the 2025–27 biennium are tracking as projected—we are 25% of the way through  
23 the biennium and have spent 18% of the approved expenditure limit. The Legislative Fiscal Office  
24 has requested 5% reduction options across funding sources due to statewide shortfalls, with  
25 decisions pending in the 2026 Legislative Session, and development of the 2027–29 budget is  
26 underway with policy option packages being drafted for submission this spring and presentation  
27 to the Commission in June 2026.

33 **EXHIBIT A: WINCHESTER WATER CONTROL DISTRICT**

34 The Commission approved the proposed order relating to, among other determinations, a  
35 requirement to install Department approved fish passage at Winchester dam prepared by the  
36 Office of Administrative Hearings, Administrative Law Judge. No new evidence was considered by  
37 the Commission. No public testimony was taken.

41 **EXECUTIVE SESSION**

42 An Executive Session was held pursuant to ORS 192.660(2)(f) to consider information or  
43 records that are exempt by law from public inspection, as well as to consult with legal  
44 counsel concerning legal rights and duties of a public body with regard to current

1 litigation or litigation likely to be filed as authorized by ORS 192.660(2)(h). The executive  
2 session was closed to the public.

3  
4 Commissioner Labhart moved to adopt the Department’s Draft Final Order, which was  
5 provided as Attachment 2. In addition, included in this motion is the Commission’s endorsement  
6 of the interpretation and application of our rules as presented in that Final Order; and especially,  
7 OAR 635-412-0005(b)(A)(ii), including the meaning of the phrase “measured above the natural  
8 ground grade line that is used to impound water” within that rule and its application to the facts  
9 of this case as set forth in the order. Commissioner Moldal seconded the motion, and the motion  
10 carried six (6) in favor; Wahl, Hatfield-Hyde, Labhart, Hall Defrees, Morrison, Moldal. One (1)  
11 opposed Spelbrink

12  
13 **ADOPT TEMPORARY RULES**

14 The Commission ratified the following temporary rules. The eight (8) temporary rules were  
15 previously adopted by the director under her emergency action authority.

16  
17 **1) 635-005-0405, 0460, 0480 Commercial Crab Late-Season Whale Entanglement Risk  
18 Reduction Measures Implementation Date**

19 Adopted 1/23/2026: effective 2/16/2026 through 8/14/2026

20 These amended rules will implement commercial crab late-season whale entanglement  
21 risk reduction measures including a 20% pot limit reduction, requirement for late-season  
22 buoy tags, and prohibition on fishing deeper than 40 fathoms on April 1 instead of May 1  
23 to reduce the risk of whales becoming entangled in commercial crab fishing gear earlier in  
24 the season.

25  
26 **2) 635-016-0500 Modify Wild Spring Chinook Regulations in Umpqua District**

27 Adopted: 12/19/2025 Effective Dates: 2/1/2026 through 6/30/2026

28 This amended rule will prohibit retention of all wild Chinook on the Mainstem Umpqua  
29 River. It will restrict harvest to one wild adult Chinook per day and ten wild adults per  
30 season on the North Umpqua River from February 1, 2026, through June 30, 2026, in  
31 accordance with the sliding scale established pursuant to the State’s Coastal Multi-Species  
32 Conservation and Management Plan (CMP).

33  
34 **3) 635-041-0063 Allow Sales of Sturgeon Caught in The Dalles Pool Columbia River Treaty  
35 Setline Fishery**

36 Adopted: 1/29/2026 Effective Dates: 2/2/2026 through 2/28/2026

37 This amended rule provides state authorization of sales of white sturgeon  
38 caught in the winter Treaty setline fishery in The Dalles Pool to reflect recent tribal action  
39 to adopt this fishery.

40  
41 **4) 635-041-0063 Allow Sales of Sturgeon Caught in The Dalles Pool Columbia River Treaty  
42 Setline Fishery**

43 Adopted: 2/11/2026 Effective Dates: 2/12/2026 through 3/31/2026

1 This amended rule provides state authorization of sales of white sturgeon caught in the  
2 winter Treaty setline fisheries in Bonneville Pool, The Dalles Pool, and John Day Pool to  
3 reflect recent tribal action to adopt these fisheries.  
4

5 **5) 635-041-0072 Allow Sales of Warmwater Species Caught in the Columbia River Treaty**  
6 **Indian Research Fishery**

7 Adopted: 2/11/2026 Effective Dates: 2/13/2026 through 3/31/2026

8 This amended rule provides state authorization of sales of yellow perch, bass, walleye,  
9 catfish, carp, and northern pikeminnow caught in a Treaty Indian research fishery in  
10 several backwater areas and sloughs of the John Day Pool to reflect recent tribal action to  
11 open this fishery.  
12

13 **6) 635-042-0145, 635-042-0160, 635-042-0170, 635-042-0180 Adopt Select Area**  
14 **Commercial Fisheries**

15 Adopted: 2/12/2026 Effective Dates: 2/15/2026 through 7/31/2026

16 These rules implement the 2026 winter, spring, and summer Select Area commercial  
17 fisheries from February 15 through July 30. The following fisheries are addressed by these  
18 rules:

- 19 • Blind/Knappa sloughs,
- 20 • Tongue Point/South Channel,
- 21 • Youngs Bay, and
- 22 • Deep River

23 Modifications are consistent with actions taken by the Departments of Fish and Wildlife  
24 for the States of Oregon and Washington at the Columbia River Compact hearing on  
25 2/11/26.  
26

27 **7) 635-023-0101 Set Recreational Retention Fisheries for Sturgeon in Bonneville and The**  
28 **Dalles Pools and Adjacent Tributaries**

29 Adopted: 2/12/2026 Effective Dates: 2/16/2026 through 4/30/2026

30 This amended rule modifies the recreational retention fishery regulations for white  
31 sturgeon on the mainstem Columbia River in the Bonneville Pool (Bonneville Dam  
32 upstream to The Dalles Dam) and The Dalles Pool (The Dalles Dam upstream to the John  
33 Day Dam) and all adjacent tributaries. Retention will be allowed only on Monday,  
34 February 16, 2026, in these areas. Modifications are consistent with actions taken by the  
35 Departments of Fish & Wildlife for the States of Oregon and Washington at a Columbia  
36 River Joint State hearing on February 11, 2026.  
37

38 **8) 635-023-0101 Set Recreational Retention Fishery for Sturgeon in The Dalles Pool and**  
39 **Adjacent Tributaries**

40 Adopted: 2/19/2026 Effective Dates: 2/22/2026 through 4/30/2026

41 This amended rule establishes two retention days for the recreational white sturgeon  
42 fishery on the mainstem Columbia River in The Dalles Pool (The Dalles Dam upstream to  
43 the John Day Dam) and all adjacent tributaries. Retention will be allowed on Sunday,  
44 February 22, 2026, and on Thursday, February 26, 2026, in these areas. Modifications are

1 consistent with actions taken by the Departments of Fish & Wildlife for the States of  
2 Oregon and Washington at a Columbia River Joint State hearing on February 19, 2026.  
3

5 Commissioner Moldal moved to ratify the seven (7) temporary rules set forth on February 20,  
6 2026, agenda, and temporary rule 635-023-0101 to Set a Recreational Retention Fishery for  
7 Sturgeon in The Dalles Pool and Adjacent Tributaries Adopted: 2/19/2026. Commissioner  
8 Morrison seconded the motion, and the motion carried six (6) in favor; Wahl, Labhart, Spelbrink,  
9 Hall Defrees, Morrison, Moldal; one (1) opposed, Hatfield-Hyde

22 **EXHIBIT C: REVIEW OF PETITION RELATED TO COMMERCIAL DUNGENESS CRAB FISHERY RULES**

23 The Commission considered an Administrative Procedure Act (APA) petition requesting  
24 modification to commercial Dungeness crab fishery rules. The Commission denied the petition.  
25

26 Commission Action: Accept Petition and Initiate Rulemaking/Deny Petition

29

30 *Presentation:* Justin provided the Commission with a presentation outlining Oregon  
31 Department of Fish and Wildlife's ongoing efforts to reduce whale entanglements in the  
32 commercial Dungeness crab fishery, driven by increasing interactions with threatened and  
33 endangered humpback whale populations. It summarizes past and current risk-reduction  
34 measures, the development of a Conservation Plan and application for a federal Incidental Take  
35 Permit under the Endangered Species Act, and the planned 2026 rulemaking process. It also  
36 reviewed an Administrative Procedures Act petition submitted by several organizations  
37 requesting additional rule changes, including pop-up gear requirements and late-season  
38 restrictions, along with public comments reflecting a mix of support and concern about  
39 economic impacts and gear feasibility. Staff ultimately recommend accepting the petition to  
40 allow rulemaking to proceed within ODFW's existing planned processes, in coordination with  
41 NOAA Fisheries.
