

# Jenkins/Otley Access Areas



The Jenkins and Otley access areas are cooperative programs between private landowners and the Oregon Department of Fish and Wildlife Access and Habitat Program to allow public hunting access on private lands and increased access to public land. The access areas are located near Diamond, OR and they provide public hunting opportunities for deer, elk, pronghorn, sage-grouse, waterfowl, chukar, California quail, and predators. All Oregon Department of Fish and Wildlife regulations and seasons apply.

**Access Allowed:**  
August 1 - March 1

**Area Regulations:**

- No ATV's on Private Land
- No Camping or night time use of private land
- No Fires, be careful with cigarettes
- No Littering, please pick up any trash including expended shells
- Report any unlawful activities
- Respect landowners' rights and needs
- Leave all gates as you found them
- Vehicle Travel only on roads mapped and posted as open access road

No permission is required to hunt on the Jenkins and Otley Access Areas, except the Jenkins bird hunting areas. Please get permission for these areas by contacting Jenkins Ranches at (541) 493-2503 between 5 pm and 7:30 pm. "Welcome to Hunt" signs are posted at all access roads. You are responsible for knowing property boundaries. Do Not Trespass on adjacent private lands. The Jenkins Access Area is adjacent to Bureau of Land Management Wilderness Areas and Wilderness Study Areas. You are responsible for knowing and following the regulations for these areas.

**Note:** Hunting on Private Land is a privilege, not a right. Private land hunting opportunities will remain in the future only if the property and rights of private landowners are respected!


