12 On Friday, **April 24, 2026, at 8:00 AM, Chair Wahl called the Oregon Fish and Wildlife**  
13 **Commission** (the Commission) meeting to order.

Expenditure Report

21 Ken Loffink, Chief Operating Officer

22

23  
24 Ken reported that as of February 28, 2026, ODFW held a total cash balance of \$149.1 million,  
25 with \$58.0 million in unrestricted funds (including \$17 million in Rock Creek Hatchery insurance  
26 proceeds) and \$91.1 million in restricted funds. True unrestricted cash totaled \$41.0 million after  
27 excluding insurance proceeds, reflecting a \$10 million decline from the prior month due to large

1 scheduled payments and pending federal reimbursements. Overall, agency expenditures are  
2 tracking as expected for the 2025–27 biennium, with 24.19% of authorized expenditures used at  
3 33% of the biennium. Revenue from recreational license sales continues to perform strongly, up  
4 28% in sales and 11% in products sold compared to 2025. Budget development for the 2027–29  
5 biennium is underway, including public budget open houses, coordination with DAS CFO and the  
6 Governor’s Office, and refinement of policy option packages.

39 The 2025 Oregon Wolf Annual Report highlights continued growth in the state’s wolf population,  
40 which increased 13% to an estimated 230 wolves across 30 packs and 23 breeding pairs,  
41 supported by extensive monitoring including radio-collars, remote cameras, and more than  
42 20,000 wolf location data points collected.  
43

1 While wolf numbers and range continued their long-term expansion, the report also notes  
2 increases in livestock depredations and a corresponding rise in authorized wolf removals,  
3 particularly in the East Wolf Management Zone, which saw the majority of the 42 total  
4 mortalities recorded in 2025.

5  
6 ODFW’s implementation priorities focused on addressing illegal take, enhancing population  
7 monitoring—including moving toward an integrated population model—and reducing  
8 wolf-livestock conflict through proactive deterrence, producer assistance, partnerships, and  
9 expanded on-the-ground support.

20 Adopted: 3/23/2026 Effective Dates: 3/23/2026 through 7/31/2026

21 These rules expand the open area for two previously adopted fishing periods in the Youngs  
22 Bay Commercial Salmon Fishery scheduled to occur from March 23 through March 25.

23 Modifications are consistent with actions taken by the Department of Fish and Wildlife on  
24 3/23/26.

25  
26 2.) 635-042-0145

27 Modify Youngs Bay Select Area Commercial Fishery

28 Adopted: 3/25/2026 Effective Dates: 3/26/2026 through 7/31/2026

29 These rules expand the open area for two previously adopted fishing periods in the Youngs  
30 Bay Commercial Salmon Fishery scheduled to occur from March 26 through March 30.

31 Modifications are consistent with actions taken by the Department of Fish and Wildlife on  
32 3/25/26.

33  
34 3.) 635-042-0145

35 Modify Youngs Bay Select Area Commercial Fishery

36 Adopted: 3/31/2026 Effective Dates: 4/1/2026 through 7/31/2026

37 This rule expands the open area for previously adopted fishing periods in the Youngs Bay  
38 Commercial Salmon Fishery scheduled to occur from April 1 through April 2. Modifications  
39 are consistent with actions taken by the Department of Fish and Wildlife on 3/31/26.

41 4.) 635-018-0090

42 Lower Deschutes River Hatchery Spring Chinook Season

43 Adopted: 4/2/2026 Effective Dates: 5/5/2026 through 9/28/2026

1 This rule is needed to allow sport harvest opportunities for returning hatchery spring  
2 Chinook salmon in the Lower Deschutes River for an approximate two-week period  
3 beginning May 5, 2026.  
4

5 5.) 635-041-0020

6 Modify the Annual Closure Period for Treaty Subsistence Fishing in the Fifteenmile Creek  
7 Sanctuary

8 Adopted: 4/7/2026 Effective Dates: 4/16/2026 through 6/15/2026

9 Under permanent rule, the closure date for treaty subsistence fishing around the mouth of  
10 Fifteenmile Creek extends from November 16 through June 15, annually. This amended  
11 rule allows subsistence fishing in this area to resume on April 16, 2026, to allow access to  
12 spring Chinook.  
13

15 Set Additional Days for the Recreational Spring Salmon Fishery in the Columbia River

16 Adopted: 4/10/2026 Effective Dates: 4/11/2026 through 6/15/2026

17 This amended rule sets Columbia River recreational spring salmon fisheries and modifies  
18 the daily bag limit for Select Area recreational salmon fisheries from March 1 through June  
19 15. Modifications are consistent with actions taken by the Departments of Fish and Wildlife  
20 for the States of Oregon and Washington on February 19 and April 9, 2026.  
21

22 7.) 635-023-0125

23 Set an Additional Day for the Recreational Spring Salmon Fishery in the Columbia River

24 Adopted: 4/15/2026 Effective Dates: 4/18/2026 through 6/15/2026

25 This amended rule adds one day to the Columbia River recreational spring  
26 salmon/steelhead fishery downstream of Bonneville Dam. Modifications are consistent  
27 with actions taken by the Departments of Fish and Wildlife for the States of Oregon and  
28 Washington at a Columbia River Joint State hearing held on April 14, 2026.  
29

31 Modifying Youngs Bay Select Area Commercial Fishery

32 Adopted: 4/17/2026 Effective Dates: 4/20/2026 through 7/31/2026

33 This amended rule expands the open area for the previously adopted fishing period in the  
34 Youngs Bay Commercial Salmon Fishery scheduled to occur on April 20. Modifications are  
35 consistent with actions taken by the Department of Fish and Wildlife on 04/16/26.  
36

27 **Exhibit B: 2026-27 GAME BIRD HUNTING REGULATIONS**

28 The Commission adopted the game bird season regulations for 2026-27.

29 *Commission Action: Rulemaking*

30 Brandon Reishus, Migratory Game Bird Coordinator  
31 Mikal Cline, Upland Game Bird Coordinator

32  
33 Mikal and Brandon proposed 2026–27 game bird hunting regulations, including upland, sage-  
34 grouse, and migratory bird seasons. They reviewed recent harvest trends, population status, and  
35 production forecasts for species such as grouse, quail, pheasant, partridge, and sage-grouse,  
36 noting generally stable frameworks with minor date adjustments. Sage-grouse population  
37 indicators are mixed, with a 17.8% spring population increase but below-average chick  
38 production; the recommendation is to maintain controlled hunt permit levels to keep harvest  
39 below 2% of the fall population. Migratory bird proposals include adjustments to duck season  
40 opening dates, white-fronted goose bag limits, and a reduced September Canada goose season  
41 in the Northwest Permit Zone.

11 The Commission adopted the 2026 sport and commercial fishery regulations for Pacific halibut.

17 Melanie outlined the proposed 2026 Pacific halibut fishery regulations, including adoption of  
18 quotas, season dates, and management measures for both recreational and commercial  
19 fisheries. Highlighting the Catch Sharing Plan for 2026, noting allocations of 297,297 pounds for  
20 Oregon recreational fisheries and 261,211 pounds for coastwide directed commercial fisheries,  
21 with seasons beginning as early as April 30 and June 23, respectively. Staff recommend adopting  
22 federal rules by reference—covering harvest levels, sport and commercial season dates, and the  
23 2026 Catch Sharing Plan.

38 fishing seasons in state-managed waters of the Pacific Ocean.

1 Presentation: Christine provided the Commission with a presentation outlining the proposed  
2 2026 ocean salmon regulations, developed through the Pacific Fishery Management Council's  
3 annual process, which emphasizes public involvement, conservation, and compliance with federal  
4 ESA requirements. Detailing management criteria such as exploitation rate limits and escapement  
5 goals for key salmon stocks, provides projected 2026 performance relative to those constraints,  
6 and presents the season structures for commercial and recreational fisheries across Oregon  
7 coastal management areas.

21 The Commission adopted rules creating a new Sauvie Island Beaches Parking Permit

22 *Action: Rulemaking*

25  
26 Steve provided the Commission with a presentation outlining the ongoing challenges and  
27 proposed solutions for managing heavy summer visitation at Sauvie Island beaches within the  
28 Sauvie Island Wildlife Area, emphasizing the impacts of overcrowding on wildlife habitat, public  
29 safety, and emergency access. Steve reviewed the success of the 2025 pilot program; such as  
30 reduced congestion, maintained emergency access, and improved visitor experience, while also  
31 noting public confusion around permitting and signage. To address persistent issues, ODFW  
32 proposed updated rules creating a limited, seasonal Sauvie Island Beaches Parking Permit for  
33 weekends and holidays between June 15 and Labor Day at high-use beaches, enabling better  
34 control of vehicle numbers. The plan for 2026 includes expanded public outreach, staffing,  
35 continued checkpoint operations on Reeder Road, and implementation of the revised permit  
36 structure.

14 Holly provided a presentation regarding the acquisition of the Don Lindly property along the  
15 Alsea River, purchased by ODFW in 2014 to support river access near the Port of Alsea Marina.  
16 The property provides a public bank-fishing area, an undeveloped launch for small watercraft,  
17 and a popular day-use site. Since acquiring the property, ODFW's partner in the acquisition,  
18 Lincoln County, has determined there is no longer support to develop the site for motorized boat  
19 access, a condition of using federal money for the acquisition. Given this change, ODFW and  
20 partners agreed to a sale of the property to the County who have committed to maintaining  
21 public access at the site. ODFW staff recommended approving the sale of the property to the  
22 county to ensure continued public benefit and allow the Department to refund the USFWS for the  
23 original purchase so the funds could be used at other boating access sites.

37 The Commission approved funding of board recommended projects.

2 Andy provided a presentation outlining the Private Forest Accord Grant Program, created through  
3 a 2021 agreement between conservation and timber groups to support aquatic resource  
4 protection and habitat conservation across Oregon. For the 2025 grant cycle, ODFW recommends  
5 funding 25 projects totaling \$10.5 million, leveraging more than \$12 million in matching funds, to  
6 improve fish passage, restore streams and wetlands, enhance beaver-modified landscapes, and  
7 support a new water-transactions category. With 80 proposals requesting over \$39 million, the  
8 selected projects represent the most impactful conservation opportunities identified by the  
9 Advisory Committee.
