Expenditure Report

Ken Loffink, Chief Operating Officer

Ken provided the Commission with a financial overview for the period ending May 31, 2026. Unrestricted cash totaled \$74 million (including \$17 million in insurance proceeds for wildfire damages), while restricted cash stood at \$95.5 million, resulting in \$169.5 million held at the state treasury. The agency saw an increase in unrestricted cash due to strong license sales in May, which is the peak month for controlled hunt applications. For the 2025-2027 biennium, expenditures are at 35% of the approved limit, and revenues from recreational licenses are tracking at 19% higher than the previous year.

38 Ken and Shaun provided the Commission with a presentation on the department's 2027-2029
39 Agency Request Budget. They outlined a strategic, collaborative approach to conservation,
40 emphasizing resilience for species, lands, and waters amid climate challenges. The budget
41 proposes \$835.7 million in total funds, an increase driven by investments in wildlife recovery,
42 stewardship, connectivity, and infrastructure, including implementation of HB 4134 and
43 landscape-scale projects. Key initiatives focus on science-based actions, stakeholder
44 engagement, and maintaining core operations, with targeted funding for habitat restoration,

1 monitoring, and public outreach. The plan leverages partnerships, prioritizes at-risk species, and
2 supports both urban and rural communities, aiming to advance Oregon's conservation goals
3 while remaining adaptable to evolving guidance from state leadership

1 **EXHIBIT C: OREGON FURBEARER TRAPPING AND HUNTING REGULATIONS**

2 The commission adopted rules for furbearer trapping and hunting for 2027/28.

3 *Commission Action: Rulemaking*

5 Sam Fino, Carnivore and Furbearer Coordinator

6
7 Derek and Sam provided the Commission with a presentation outlining the proposed
8 2026-2028 furbearer regulations. They emphasize data-driven management for long-term
9 population health, including mandatory harvest reporting, biological sampling, and habitat
10 restoration efforts. Key proposals include incorporating recent bill language prohibiting beaver
11 harvest on impaired waterways on public lands while also maintaining current beaver harvest
12 reporting and seasons, keeping river otter harvest open statewide, and enforcing trap restrictions
13 in certain national forests. Harvest data from 2023-2025 shows most activity occurs on private
14 land and navigable waters, with minimal public land harvest. Staff recommend no changes to
15 bobcat bag limits or harvest seasons for several other species, and highlight ongoing education,
16 outreach, and public input as integral to regulation development

31 *Commission Action: Rulemaking*

Cassie and Chris provided the Commission with a presentation on the proposed 2026 Oregon Coastal Wild Fall Salmon Angling Regulations. The proposed rules revised regulations for wild fall Chinook and coho salmon based on annual population reviews and restructured the rules for consistency and clarity. Wild fall Chinook harvest is managed under frameworks in the Coastal Multi-Species Conservation and Management Plan and Rogue Fall Chinook Conservation Plan, which scale harvest to population health. Based on the annual review, wild fall Chinook retention was proposed to be open in 18 coastal basins, with increased bag limits in several basins compared to 2025. Coho salmon runs continue to be strong, reflecting conservation successes. Multiple state and federal plans guide management and conservation of coastal coho salmon, and wild coho salmon fisheries require federal approval. The department proposed wild coho salmon fisheries in 10 coastal basins projected to meet fishery mortality and spawning escapement criteria; fisheries were not proposed in the Alsea and Umpqua basins because they are not projected to meet escapement criteria. Overall, the 2026 proposed fall coastal fisheries allow for robust opportunity in most basins while ensuring sustainability of runs and protection of weak stocks.

Commissioner Spelbrink moved to direct department staff to ask National Marine Fisheries Service (NMFS) to approve an Alsea Basin wild coho fishery designed to remain below the designated exploitation rate. Ideally a minimum of 30 open days with a one and three bag limit. Commissioner Hall Defrees seconded the motion, and the motion was carried seven (7) in favor; Wahl, Hatfield-Hyde, Labhart, Spelbrink, Hall Defrees, Moldal, Morrison.

EXHIBIT E: COMMERCIAL COASTAL PELAGIC SPECIES FISHERIES RULE AMENDMENTS

The Commission adopted rules for Sardine harvest in 2026/27.

Commission Action: Rulemaking

Lynn Mattes - Marine Fisheries Management Section Leader

Lynn provided the Commission with a presentation outlining the biology, distribution, and fluctuating abundance of Pacific sardines, emphasizing that population trends are driven by ocean conditions. It detailed the federal management framework for the 2026-2027 fishery, including scientific surveys, stock assessments, and harvest control rules. Key regulatory measures for the upcoming season are based on a stock biomass of 30,158 metric tons, with specific limits set for overfishing, acceptable biological catch, annual catch, and target levels. The Council prohibits directed fisheries when biomass falls below 150,000 metric tons but allows limited harvest for live bait, minor fisheries, and incidental catch. Accountability measures and ongoing research may lead to management changes starting in the 2027-28 fishery, as new findings suggest a single panmictic stock for Pacific sardine.

EXHIBIT F: OREGON CONSERVATION & RECREATION FUND PROJECT APPROVAL

The Commission approved funding for the Oregon Conservation and Recreation Fund (OCRF) Advisory Committee's recommended projects.

Reva provided the Commission with a presentation on the Oregon Conservation and Recreation Fund (OCRF) Advisory Committee's recommendation to approve funding for 19 diverse conservation and outdoor recreation projects totaling \$436,297, selected from 90 proposals statewide. The projects span a wide range of ecoregions, species, and applicant backgrounds, including initiatives to assess gray whale health, save the Mazama newt, engage underserved youth in bilingual wildlife education, and reconnect Indigenous families to ancestral waterways. Notably, 68% of the selected projects are new grantees, advancing the goals of the State Wildlife Action Plan (SWAP) and promoting outdoor equity. The staff recommends commission approval, emphasizing the program's commitment to science-based conservation, research, and broadening access to outdoor opportunities.

21 hatchery improvements; staff recommended approving these projects as proposed by the
22 Restoration and Enhancement Board, emphasizing their alignment with Oregon Department of
23 Fish and Wildlife's goals for habitat restoration and fisheries enhancement.
