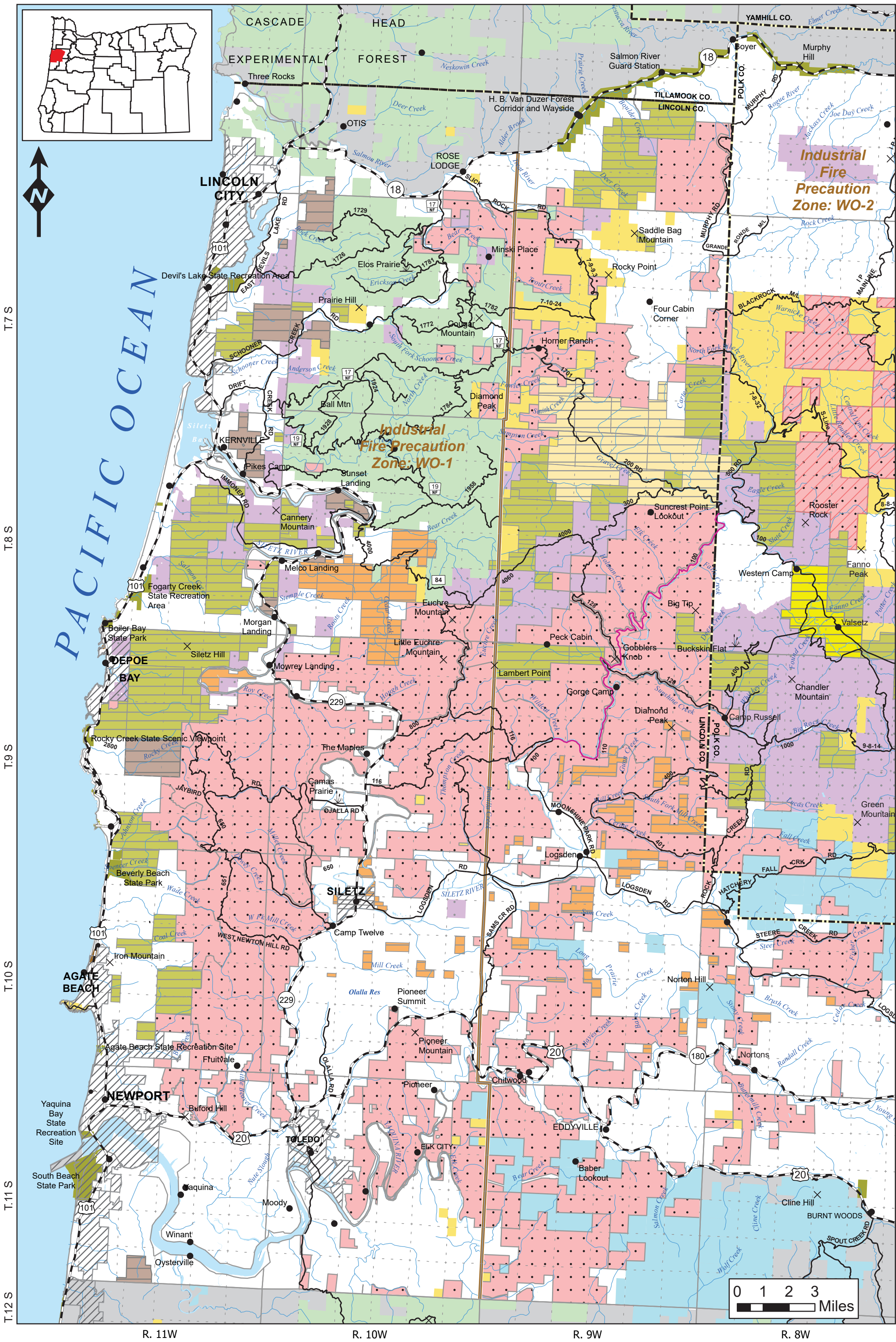

Posted Yellow Travel Management Area signed roads are closed to motor vehicles year round. For fire restrictions contact Manulife. When lands are open, access is permitted 1 hour before sunrise to 1 hour after sunset.
 - Weyerhaeuser contact: (888-741-5403)
Posted Yellow Travel Management Area signed roads are closed to motor vehicles year round. At Fire season level 3 all roads are walk in only, no motor vehicles. At fire season level 4 no public access. When lands are open, access is permitted 1 hour before sunrise to 1 hour after sunset.
 - The only exception is the Mill Creek drainage located in Polk County, which is closed to motor vehicles at the start of fire season and reopened when its over.

The Stott Mountain - North Alsea Travel Management Areas are cooperative access programs with several public and private landowners. The program helps control wildlife damage and maintains public hunting access on private and surrounding public land. The TMAs provides public hunting opportunity for deer, elk, bear, cougar, and game birds. All Oregon Department of Fish and Wildlife Regulations and Seasons apply. Area may be closed during high fire danger. Landowner designations on the map may vary in accuracy due to frequent land exchanges. Many of the roads that are closed to motor vehicles by gates, posted signs or barriers are open for walk-in hunting only. Not all landowners on this map are program cooperators, and some areas may be closed to public hunting. Some cooperator's lands may not be enrolled in the TMA; be sure to reference the map to know what lands are enrolled. Please contact individual landowners about their access policy and current closures. - General Area Regulations**
- No forest products removed without permit
 - Private lands closed to the public 1 hour after sunset to 1 hour before sunrise
 - Siletz Gorge Road from Wildcat Bridge to Gravel Creek open weekends only
 - Do not block gates
 - No Camping
 - No Target Shooting
 - No Trapping without private landowner permit/permission
 - No Motorcycles or ATVs
 - No Electric Bikes
 - Motor Vehicles On Rocked Roads Only
 - No Fires, be careful with cigarettes
 - No Littering, pick up any trash
 - Report any unlawful activities
 - Respect landowners rights and needs
 - Hunting, locating, or scouting for the purpose of hunting wildlife with infrared (thermal) or night vision equipment is prohibited
